PART B. Foreign Individuals and Business Entities

Charles Town is pleased to have foreign visitors participate in our racing contests. We appreciate how complex our Federal Tax Laws can be and because this complexity here are the rules and forms needed to benefit of a treaty country and not be subject to mandatory withholding of 30%.

All foreign individuals and foreign businesses are subject to a 30% withholding for all earning from U.S. sources.

Certain countries have signed treaties with the U.S. where foreign individuals and companies can complete certain specific steps to not be subject to the mandatory 30% withholding.

The Countries with active treaties are changing frequently and the Horsemen Bookkeeping Staff are not expected to be knowledgeable on these changes. When this office can not establish the correct treaty in operation, the 30% withholding will be honored.



The foreign individuals are responsible on their own to obtain a proper U.S. taxpayer identification number (TIN) to correctly complete a W-8BEN or a W-8ECI along with a copy of the IRS TIN notification.

Lacking this number and a copy of this form will result in an automatic withholding of 30%. There are no exceptions to this rule.
